

ACCOMACK SOLID WASTE MANAGEMENT RESOLUTION

A JOINT SOLID WASTE RESOLUTION

BY PARTICIPATING JURISDICTIONS
WITHIN ACCOMACK COUNTY

TO JOINTLY PROMOTE THE HANDLING OF SOLID WASTE

WHEREAS, sound solid waste management practices are vital to all citizens within Accomack County and its incorporated Towns; and

WHEREAS, the Virginia Department of Environmental Quality has developed regulations for the development of solid waste management plans; and

WHEREAS, under the Virginia Department of Environmental Quality Regulations for the Development of Solid Waste Management Plans, May 15, 1990, jurisdictions can join together for joint development, adoption and implementation of a solid waste management plan; and

WHEREAS, participating jurisdictions within Accomack County may recognize that, due to economies of scale, it is in the best interest of a jurisdiction to participate in a countywide solid waste management plan for the purpose of meeting the Department's regulations for solid waste management plans; and

WHEREAS, pursuant to the provisions of Section 15.1-21 Code of Virginia of 1950 as amended, any power or powers, privileges or authority exercised or capable of being exercised by a political subdivision may be exercised jointly with another subdivision; now

THEREFORE, BE IT RESOLVED BY THE PARTICIPATING JURISDICTIONS WITHIN ACCOMACK COUNTY AS FOLLOWS:

- (1) That the participating jurisdictions request the Department of Environmental Quality to designate the County of Accomack as the Accomack Solid Waste Management Region for the purpose of meeting the Department's regulations for the development, adoption, and implementation of a solid waste management plan.
- (2) The Accomack County Public Works Department shall serve as the staff to the said County and the incorporated towns electing to participate.

- (3) That Accomack County will be responsible for carrying out the provisions of the plan.
- (4) That this Agreement between the County and the participating municipalities shall be perpetual unless terminated in accordance with the provisions of Paragraph 5 below.
- (5) That this Agreement may be canceled by a participating jurisdiction (County or town) by giving written notice, by registered or certified mail, to the highest elected official of the County or town.
- (6) That termination of this Agreement by a participating jurisdiction, in accordance with the provisions of Paragraph 5 above, shall not affect the existence of the agreement between the County and any other cooperating municipality.
- (7) That this Agreement shall be deemed to be effective upon the adoption of this Agreement by the Council of the Municipality and the Accomack County Board of Supervisors.

BE IT FURTHER RESOLVED that the highest elected official of each jurisdiction shall certify a true copy hereof to each participating jurisdiction.
