Council Discussion: Old Business

- 1. Proposed Food Truck Ordinance 23-01- Councilman Nicholson made a motion to pass the proposed ordinance, seconded by Councilman Taylor. The motion passed.

He also spoke about how the Facebook article written by the Eastern Shore Post had received hundreds of comments, but that no one showed up in person to present their concerns or comments. Mayor Russell spoke about how the issues with the current food truck have been somewhat costly and that they had





violated our ordinance by illegally connecting the food truck to the Town septic supply, dumped water illegally, and dumped buckets of grease behind the food truck.

- Laptop- Clerk Lewis presented a quote for the laptop to be purchased with the ARPA- Law Enforcement Technology Grant in the amount of \$584.54 from Amazon. Councilman Taylor made a motion to approve the purchase. Seconded by Councilman Welch. Motion passed unanimously.

- **R. Taylor-** Regarding Ordinance 23-01 Governing the Use of Mobile Food Truck Units; Councilman Taylor made a motion to allow the existing food truck to continue to operate until their business license expires and then they would have to fall into compliance with the ordinance. The motion was not seconded and died.
- S. Welch Councilman Welch reminded everyone of our Annual Trunk-or-Treat event on 10/31.





- J. Welch- Councilwoman Welch noted the Neuter Scooter was coming on 10/16 & 10/17.
- **H. Nicholson-** Councilman Nicholson stated the water line repair on Bennett Street was almost complete. We are waiting on the asphalt to be available. He stated we are responsible for 2 years for the repair and we would start 'cold-patching' the area tomorrow, 10/10. He also stated we will begin picking up and chipping limbs/debris as soon as we're able. The dump truck was broken and has been repaired.
